Dear Resident of Town of Balgonie,



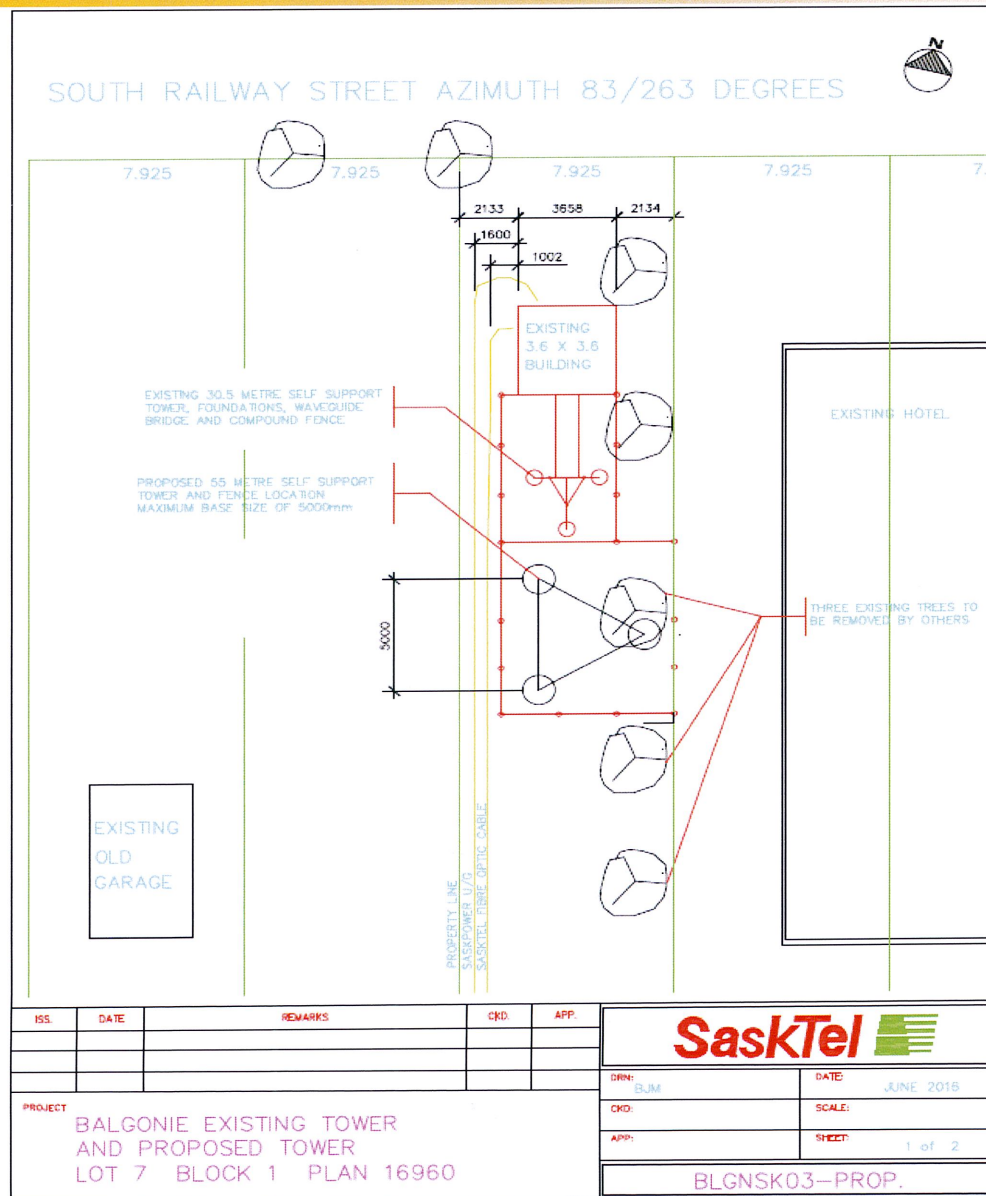
As more Canadians rely on wireless phone services for personal security, convenience, and business. SaskTel is required to respond to the demands of our customers by completing network expansion and improvements.

In order to allow for improved and additional wireless services in your community, we have applied to build a new communication facility to support the requirements of wireless services. SaskTel proposes to design and construct a new wireless facility in the Town of Balgonie in order to provide enhanced wireless communications in Balgonie and area. The existing wireless facility will be removed upon completion.

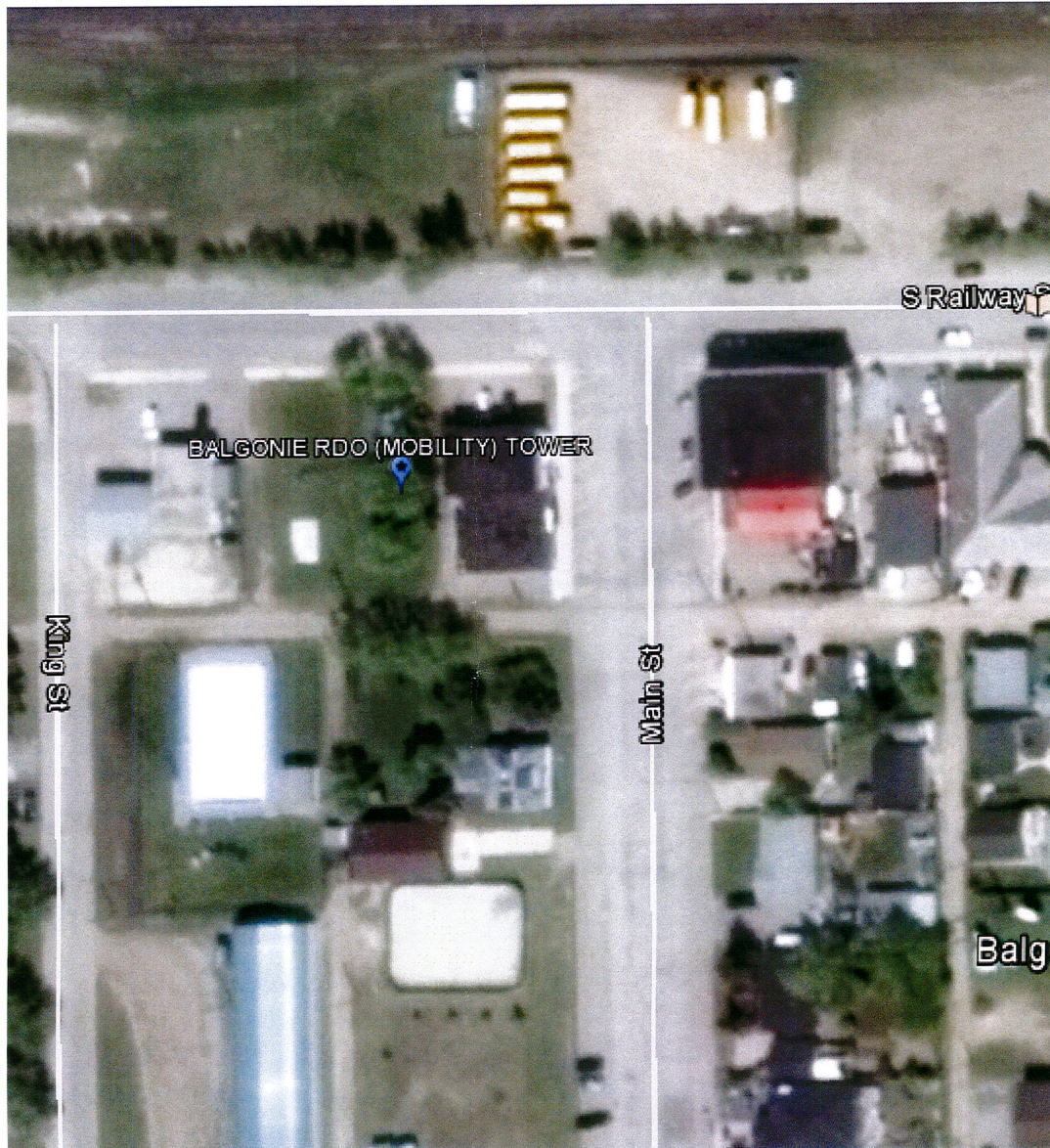
Other Infrastructure

Proposed tower will be located on SaskTel's property 113 South Railway Street, Surface Parcel # 110343899, Lot 7, Block 1, plan 16960 in the Town of Balgonie.

Safety Code 6

The operation of all radio frequency equipment in Canada is regulated by a Health Canada safety code called Safety Code 6 – Limit of Human Exposure to Radiofrequency Electromagnetic Fields.

I, Bryan Sivertson on behalf of SaskTel, attest that the radio installation described in this notification package will be installed and operated on an ongoing basis so as to comply with Health Canada's Safety Code 6, as may be amended from time to time, for the protection of the general public including any combined effects of nearby installations within the local radio environment.

Access

The Self Support Tower will have anti climb device installed on the Tower.

Transport Canada

Site will meet necessary aeronautical obstruction marking requirements including painting and/or lighting as per Transport Canada request.

Environmental

The *Canadian Environmental Assessment Act* ensures that the installation and modification of antenna systems is done in a manner that complies with appropriate environmental legislation.

I, Rob Kaminski on behalf of SaskTel, attest that the Tower installation described in this notification package falls under the exclusion list according to Schedule 1, Section 2, Part 1 General Projects – Section 20 (a) (i) & (ii) of the Act.

Tower Structure

I, Jason Barsch, on behalf of SaskTel, attest that the Tower installation described in this notification package will be engineered, constructed and maintained in accordance with Canadian Standards Association specification "S37-13 Antennas, Towers and Antenna-Supporting Structures", as amended from time to time, for the protection of the general public respecting good engineering practices including structural adequacy.

All drawings and final designs will be reviewed and stamped by a Consulting Engineer licensed by the Association of Professional Engineers & Geoscientists of Saskatchewan.
