A presentation by G.Syrota of Bylaw Enforcement Services for the Town of Balgonie. The Commissionaires are providing services to 55 communities. Half of the Commissionaires are retired law enforcement officers. Services may be provided seasonally or annually. The Commissionaires will have the ability to enforce the bylaws that Town Council directs them to, and they will apply the bylaws objectively. The Commissionaires would require that any complaints about bylaw contraventions in writing. A suggested starting point for service would be 5 hours per week from May to October and 3 hours bi-weekly from November to April. The time spent in the community would be flexible. Services that would not be provided include dog control and moving traffic violations.
