TOWN OF BALGONIE BYLAW NO. 452/2023

A BYLAW TO REQUIRE CRIMINAL RECORD CHECKS WITH NOMINATION FORMS.

The Council of the Town of Balgonie, in the Province of Saskatchewan, enacts as follows:

- 1. Every candidate for municipal office shall obtain a current criminal record check at their own expense.
- 2. The criminal record check includes:
 - a) Form B.1 prescribed in The Municipalities Regulations; and
 - b) The document provided by the police service.
- 3. The criminal record check shall be included with, and form part of the nomination papers submitted by the candidate for municipal office.
- 4. This bylaw shall come into effect on July 24th, 2023.
- 5. This bylaw repeals Bylaw No. 390/2016.
