- the Town of Balgonie presently has a new Official Community Plan and Zoning Bylaw and an annexation proposal for the area into Community Planning for review and approval;
- once the bylaws and annexation are approved the Town will rezone the above subdivision High Profile Commercial to accommodate the planned development;
- the subdivision should be reviewed in the context of the new Official Community Plan and Zoning Bylaw for the town; and,
- the Town notes that both the water and sewer are proposed communal and municipal which will be from the Town of Balgonie; and,

that the Town of Balgonie supports this proposed commercial subdivision of NW ¼ 33-17-17 W2M in the R.M. of Edenwold No. 158, with the provision that, in order to cover the development that will be within the town boundaries after the annexation approval, the Town of Balgonie requires the service agreement for this development be signed with the Town.

Honourable A.Scheer met with Council to discuss current issues for the Town of Balgonie. The items of discussion included the Building Canada Fund Grant application for the lagoon expansion project and the Regina Bypass Project. Council stated the need for the lagoon expansion and the prevention of future emergency wastewater discharges. Council indicated support for the Regina Bypass Project, however, stated concerns of safety and access with the current plan to close Main Street access entirely from Highway #1. Council also described the completion of the Water Transmission Line from Pilot Butte and the pressures from regulatory bodies and its impact on the Town of Balgonie's resources and ability to keep up with aging infrastructure.
