BYLAW NO. 404/2018

A BYLAW TO AMEND BYLAW NO. 178/1990 KNOWN AS THE TRAFFIC BYLAW

The Council of the Town of Balgonie in the Province of Saskatchewan enacts as follows:

Bylaw No. 178/1990 is amended as herein set forth.

1. Part I, Section (2) of the Traffic Bylaw 178/1990 is amended by deleting the existing definition of "Heavy Vehicle" and by substituting the following definition:

"Heavy Vehicle" means:

- (i) A motor vehicle with a gross weight registration exceeding five thousand kilograms (5,000 kg)
- (ii) A vehicle, including any combination of motor vehicle, trailer and load, with a total weight exceeding five thousand kilograms (5,000 kg).
- 2. Part I, Section (2) of the Traffic Bylaw 178/199 is amended by adding the "recreational vehicle" to the definition as follows:

"Recreational Vehicle" shall mean a self-propelled or towed vehicular type unit, primarily designed as temporary living quarters for recreational, camping or travel use and which is used solely as a family or personal conveyance and in no way used for commercial purposes. Without limiting the foregoing, recreational vehicles include:

- (i) Travel trailer
- (ii) Cabin trailer
- (iii) Tent Trailer
- (iv) Truck Camper
- (v) Motor home
- (vi) Park trailer
- (vii) Fifth-wheel travel trailer
- (viii) Boat trailer
- (ix) Utility trailer
- 3. Schedule "O" of Traffic Bylaw 178/1990 is amended by removing the voluntary payment for Part 2, Bylaw sections 7 (1) and 7 (2) for the offences of driving off of a heavy vehicle route and failure to proceed to a weigh scale.
- 4. Part III of the Traffic Bylaw 178/1990 and Schedule "A" is amended by deleting Part III and Schedule "A" with respect to Heavy Truck Routes and substituting the following Part III and Schedule "A":

Part III: TRAFFIC ROUTES:

- (1) No person shall operate a heavy vehicle on any street except:
 - (a) Upon the streets set out in Schedule A to this Bylaw which streets are hereby established as heavy vehicle routes:
 - (b) While such heavy vehicle is making collection or delivery, provided that the operator proceeds by the most direct route to or from the point of collection or delivery, as the case may be, to or from the nearest heavy vehicle route;
 - (c) While such heavy vehicle is being operated in the service of the Town.
 - (d) A recreational vehicle, provided that the operator proceeds by the most direct route to or from a residence or business, to or from the nearest heavy vehicle route.

- (e) School busses, provided that the operator drives along the acceptable bus route provided by the Municipality.
- (2) No operator of a vehicle shall fail to comply with a request of a Police Officer or Special Constable to immediately proceed to a weigh scale and there allow the vehicle to be weighed for the purpose of determining whether the vehicle is a heavy vehicle.
- (3) A person contravening any provisions of this bylaw shall be guilty of an offence and is liable to a penalty of:
 - First offence \$100.00 i)
 - ii) Second offence \$200.00
 - Third offence \$300.00 iii)
- (4) A person contravening any provisions of this bylaw who has been served with a summons ticket and the penalty is \$300.00 or less and who wishes to plead guilty and pay a voluntary payment within 14 days of the date of the summons ticket, may deliver the summons and an amount equal to 50% of the specified penalty sum for the offence to place indicated on the summons ticket and or before the date specified on the summons.
- 5. This bylaw shall come into effect on the day of its final passing.

READ A SECOND TIME THIS 23RD DAY OF APRIL, 2018.

READ A THIRD TIME AND PASSED THIS 23RD DAY OF APRIL, 2018.


