D.Campbell emphasized the importance of having back-up generators ready and operational for an Emergency Operations Center (EOC) in an emergency situation. He stated the questions and items listed in this questionnaire are procedures which have been in place for many years and that the Volunteer Fire Departments in Balgonie, Pilot Butte, White City and the Village of Edenwold have historically worked together very well in keeping our communities safe. The Regional Emergency Preparedness Plan for White Butte should be evaluated on the assets each community is bringing to the plan and the benefits potentially received. D.Campbell expressed concerns regarding the size of White Butte Regional Planning Committee area with potential R.M. of Sherwood membership on the White Butte Regional Committee.

KIEL/LAPCHUK that a letter be sent to the Minister of Highways and Infrastructure, Honourable Nancy Heppner, with respect to the information Ron Gerbrandt, Assistant Deputy Minister, Brent Miller, Director, and Jeffrey Holland, Senior Project Manager, Highways and Infrastructure - Design and Innovation Division, presented at the meeting held on September 11, 2014 in Balgonie; and, that the letter addresses the following;

- 1. The closure of Main Street.
 - All traffic would have one exit using Highway 46.
 - Detrimental to the businesses in Balgonie and to the growth of the town.
 - Presents traffic and emergency safety issues.

The westbound access to Main St. from Highway No. 1 needs to remain open. The west bound exit from Main St. to Highway No. 1 needs to remain open.

- 2. Traffic lights are required on the planned access onto Highway 46 in order to accommodate the high volume of traffic from Balgonie and area, Village of Edenwold, the schools and future commercial development.
- 3. The proposed traffic circle creates the potential for a greater number of accidents.
 - Drivers are unsure of how to maneuver through this type of roadway.
 - Large numbers of vehicles in this area at three peak periods during the day.
 - Large numbers of semi-trailer traffic on Highway No. 46.
 - Farm equipment would use this route to cross Highway No. 1.
- 4. The Town expects that Balgonie receive the same consideration regarding the overpass design as was given at other intersections to Highway No. 1; and, that the design be amended and approved to construct an overpass at Balgonie instead of the traffic circle.
