that S.McBain, Town Superintendent, be authorized to purchase the two additional reverse osmosis water treatment units (one pod) from Sapphire Water at a cost of \$340,000.00 per unit plus taxes as per their quote and pending approval from the Building Canada Fund Oversight Committee to include the two units (one pod) in the Balgonie Water System Upgrade Project No. 26478; and,

that the Town will be responsible for any costs associated with the purchase of the two additional water treatment units (one pod) beyond the maximum Building Canada Fund approved funding for this project.
