### **MARCH 11, 2013**

The regular meeting of Council of the Town of Balgonie was held in the Administration Building, Balgonie, Saskatchewan on Monday, March 11, 2013.

#### **PRESENT:**

Deputy Mayor Lovelace, Councillors Kiel, Solie, Wagner, S.McBain, Town Superintendent, D.Lane, Assistant Administrator and V.Hubbard, Administrator.

# **CALL TO ORDER:**

A quorum being present Deputy Mayor Lovelace called the meeting to order at 6:30 p.m.

**107/2013 WAGNER/SOLIE** that the minutes of the regular meeting of February 25, 2013 be approved as circulated.

**108/2013 WAGNER/SOLIE** that job tasks requested by Council members for the maintenance staff be emailed to Town Foreman, T.Morris by the Administrator, V.Hubbard.

#### **DELEGATION:**

**6:30 p.m.** - W.Joyce explained the need for residential sprinkler systems in homes. He advised that The Co-operators are giving homeowners insurance discounts when residential sprinkler systems are installed.

Mr. Joyce explained that the cost of the sprinkler system is approximately \$1.50 to \$2.50 per square foot. They operate using the residential household water pressure; however, farms/acreages may have to install an additional small pressure system.

D.Campbell entered Chambers. 6:40 p.m.

Mr. Joyce would like to see towns and villages pass a bylaw for the residential sprinkler systems. He then showed a video of the benefit of the residential sprinklers.

Councillor Wagman entered Chambers. 6:45 p.m.

W.Joyce left Chambers. 6:55 p.m.

**7:00 p.m.** - D.Campbell explained the need for a newer fire truck. He has priced out a unit for \$240,000.

Mayor Thauberger entered Chambers. 7:00 p.m.

The truck is newer and more multifunctional than our current equipment. Another door would be required on the fire hall. The cost of an expansion to the fire hall is unknown at this time.

He estimated the Town could still get \$19,000 to \$20,000 for our older fire truck.

D.Campbell left Chambers. 7:10 p.m.

Town Superintendent, S.McBain, discussed:

The cost of the structural inspection on the curling rink-budgeted item.

The access to the lagoon. S.McBain will set up a meeting with A.Matt to discuss road allowance options.

S.McBain and D.Campbell (EMO Co-ordinator) attending a spring run-off seminar on Tuesday, March 12, 2013 in Fort Qu'Appelle.

S.McBain asked Council if they wished to have some sandbags filled. He advised Council that all pumps, etc. would be ready to go in case of a potential flood.

Councillor Kiel indicated that, at the last White Butte Recreation meeting, some communities were expressing interest in a White Butte Region multi-use facility. They discussed the proposal to add a \$100 annual recreation charge on taxes and a user fee for the facility.

Mayor Thauberger indicated that Prairie Valley School Division's second highschool is still under discussion.

A maintenance personnel meeting was moved from March 8 to a date to be determined. Councillor Solie will advise.
